BIP - At the border veterinary, fitosanitary and health inspection are established. Import and export clearance is possible.

ATA – It is possible to perform all procedures under ATA Carnet.

UVOZ/IZVOZ – Import and export clearance is possible for goods which are not subject of inspection surveys (veterinary and fitosanitary survey).
