The Mixed Chambers Council was established with the Chamber of Commerce and Industry of Serbia, as a platform for the development and strengthening the mutually beneficial, continued, and long-term cooperation.

The objective of the Council is to bring closer and link the international business associations active in Serbia with the Chamber of Commerce and Industry of Serbia, as an umbrella organization of the Serbian economy, and to contribute, with joint efforts, to upgrading of the business and investment environment in the Republic of Serbia, strengthening of the bilateral cooperation through a common activity plan, increased activities on attracting foreign investments, and developing a local supply network, as well as better positioning of Serbian companies in the international market.

The Mixed Chambers Council started its work in July 2016, when its first meeting was held.

In September 2016, with the signing of the Agreement on Establishment of the Mixed Chambers Council, the work of the Council was made official.
